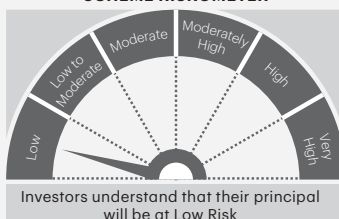

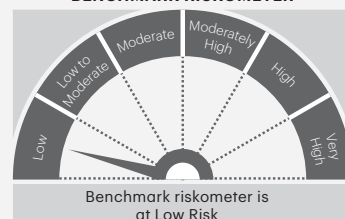
SCHEME RISKOMETER

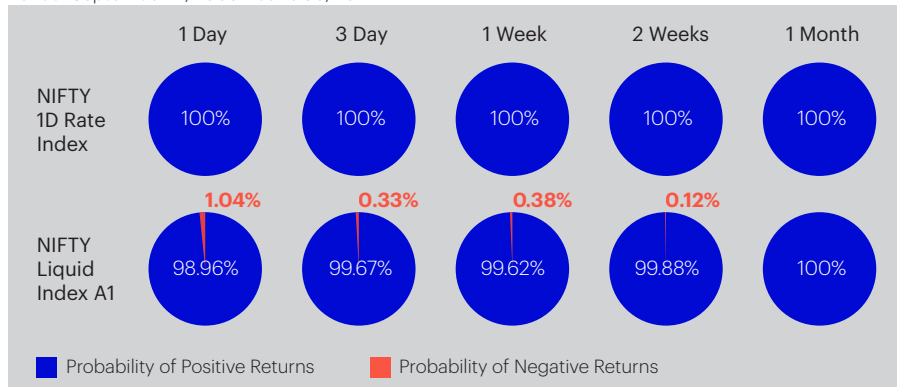

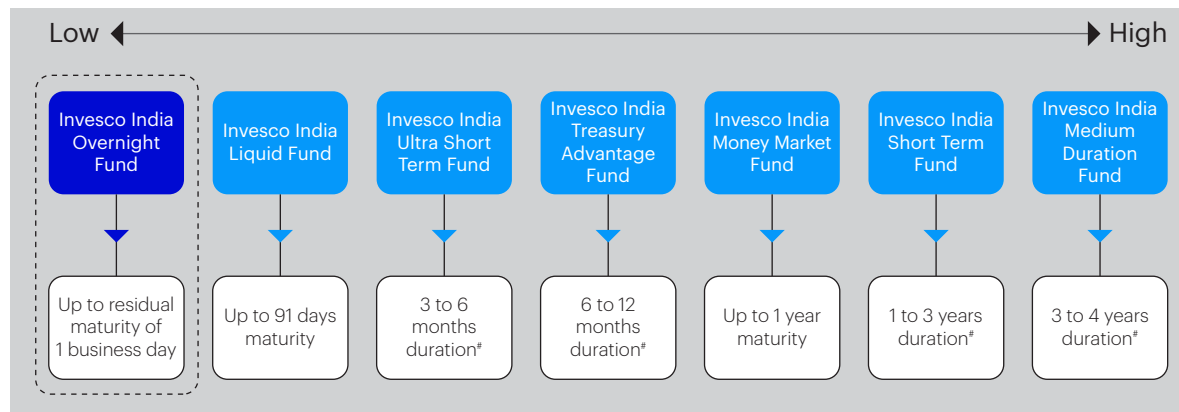

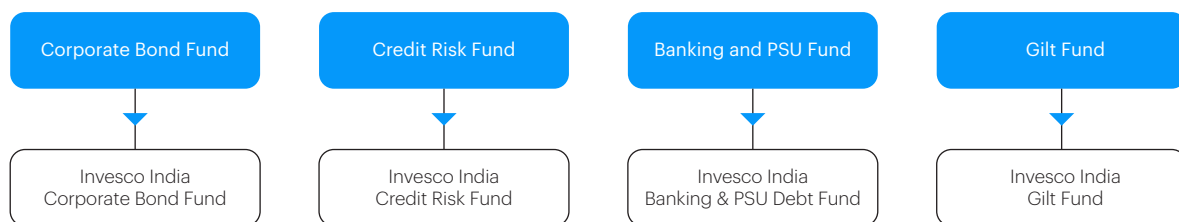
Fund Positioning

Macaulay duration of a bond is the number of years taken to recover the initial investment of a bond. It is calculated as the weighted average number of years to receive the cash flow wherein the present value of respective cash flows is multiplied with the time to that respective cash flows. The total of such values is divided by the price of the security to arrive at the duration.

Investment Universe & Strategy

The fund will invest 100% of its assets in debt and money market instruments with residual maturity upto 1 business day that may include:

- Tri Party Repo (TREPS)
- Repo
- Reverse Repo
- Certificate of Deposit (CD)
- Commercial Paper (CP)
- Cash Management Bills, T-bills and Government securities
- Other debt and money market instruments¹

Investment Objective

To generate income commensurate with low risk and high liquidity by investing in overnight securities having residual maturity of 1 business day.

Debt securities would include all debt securities issued by entities such as banks, companies, public sector undertakings, municipal corporations, body corporates and will also include central government securities, state development loans, oil bonds, fertilizer bonds, food bonds, UDAY bonds, recapitalization bonds, municipal bonds and G Sec / corporate debt repos and any other instruments as permitted by regulators from time to time.

The Scheme may enter into repos /reverse repos as may be permitted by RBI. From time to time, the Scheme may hold cash. A part of the net assets may be invested in the TREPS, repo or in an alternative investment as may be provided by RBI to meet the liquidity requirements.

The Scheme can deploy, not exceeding, 5% of its net assets in Government Securities and /or Treasury bills with a residual maturity of upto 30 days for the purpose of placing the same as margin and collateral for certain transaction.
